## Aims of today:



- Identify principles of Terms and Conditions to realise the potential of the Strategic Aims
- Identify why users access data
- Identify why providers wish to share data
- Identify ways to ensure that users and data providers are more efficiently accommodated

- I am a public user. I have just registered on the NBN Gateway. I want to use the data for personal interest
- I am a Local Record Centre. I want to share my data via the NNB Gateway, and also receive data from the NBN Gateway for use in the ordinary course of my business which involves local chargers to recruit costs on a data management
- I am a Statutory Agency. I want to go in and make use of the data I have access to and not worry about the terms between different providers
- I am an environmental consultant. I want to use data on the NBN Gateway to help inform desktop searches
- I am a researcher. I want to use data on the NBN Gateway for robust analysis
- I am a user within the GBIF community. I want to use NBN Gateway data via GBIF (public level of access rather enhanced)
- I want to exploit this data to make commercial gain from a windfarm development

 Results of Gateway questionnaire suggest that one of the key reasons for people supplying data to the NBN Gateway is to share it for research – though the T&C prevent this!
