2. Update on the Review of the Biological Recording Infrastructure

EW gave a presentation on progress and outputs from the workshops so far, and facilitated a discussion about the design of the future workshops.

Workshop 1 (Data Flow) held on 18/19th September, and Workshop 2 (Services) held on the 17/18th October

A summary of the content of each workshop and their respective outputs was provided. In the case of Workshop 2 the outputs were in draft format [although since the meeting they have been made available on our web pages]. The outputs from Workshop 1 are already available from the web pages.

It was noted that the draft Questionnaire and Interview findings have been used to inform the workshops. Once finalised these findings will be published on our web pages but in the meantime the Interview 'Rich Pictures' will be uploaded to the web pages.

Workshop 3 (Governance) on the 9/10th November, and Workshop 4 (Funding) on the 4/5th December

It was agreed that the design principles for each workshop must be underpinned by the principles adopted for the previous workshops to ensure that decisions made in these workshops are not undermined. It was also agreed that in Workshop 3 the Governance model that is in current use ought to be one of the models that is discussed.

The discussion was wide ranging and welcomed by the Working Group. The comments will help to shape the workshop designs.
