Three strategic actions have been carried over into 2018/19. These actions and the reasons for non-completion in 2017/18 are:

- Phase 2 of the Enhanced Access to Sensitive Species Data funding was not secured in time by country agencies
- Stakeholder workshops partners were not ready for workshops in 2017/18
- Development and implementation of customisable user pages delay in recruiting developer and

This is an increase of 30 members, 5 organisations and 25 individuals.
