# 2. Update on the Review of the Biological Recording Infrastructure

## Feedback on how the Review has been received - Rachel Tierney

The Final Report on the Review's recommendations was published on 14 November 2018. Group members shared their views on how the report has landed with their contacts. It was generally agreed that the response has been positive with organisations making space for discussion about what the recommendation may mean for them. There is also interest in what happens next.

It was commented that over the years the same issues have tended to come up time and again in conversation. These issues are now all addressed in the recommendations and we now need the resources to realise change.

One outcome of the current advocacy work has been an opportunity to convene a meeting with policy leads at the Scottish Government. We are aiming for inclusion in the 2019 'Programme for Government'. Resources are required to take this work forward.

## Organogram - discussion - Rachel Tierney

The organogram in its latest format was discussed, with attendees contributing useful information about their connections to the different groups, as well as connections between the groups, and names of additional groups not already included. The diagram is a living document that will be continually revised and updated and will be very useful for informing future actions and priorities.

## Prioritisation of quick wins and next steps - Ellen Wilson

A briefing note containing suggestions for short term and long term actions for the next SBIF Action Plan had been circulated. It is recognised the plan needs to be focussed and that funding will be required to support any projects.

RT is currently distilling the recommendation's benefits by sector into a series of focussed web pages and it was agreed this will be very useful. Other priorities include:

- To secure the continuation of the Development Officer role. Further discussion will be required with SNH. The role has been included in SWT's forward plan.
- To plan for a Holyrood event after March (see below)
- To arrange meetings with key parties to review the recommendations and develop a shared roadmap. The LERCs would welcome updates and a meeting in the new year.
- To seek funding to establish the NBN Scotland sooner rather than later to improve the sustainability of the infrastructure.
- To seek funding to establish and / or contribute to discreet projects, such as the new UKwide group that has been established to support the development of Recorder 6.
- To consider if there are any quick wins achievable within 3-6 months.

## Planning for an event at Holyrood – Rachel Tierney

The protocol for running an event at Holyrood requires it to be sponsored by an MSP. The plan is to work with one of the species champions to act as our sponsor, and who will also table a motion that will trigger a debate on the Review recommendations. The venue is free to use but the catering would need to be paid for. All MSPs would be invited. The best timing for the event would be after March 2019.
