#### **Recorder 6 Steering Group**

# **Terms of Reference**

#### Aim

The Recorder 6 Steering Group aims to ensure Recorder 6 users are able to preserve the structure and integrity of biodiversity datasets held within Recorder 6, and can continue to manage and use their data-holdings effectively.

To achieve this aim the Recorder 6 Steering Group will work to secure new arrangements for maintenance and development of Recorder 6 in its current form and look to develop a successor system which will replicate the Recorder 6 data model on a modern development platform – providing an easy data migration path for existing Recorder 6 users.

In doing so, the Group will make decisions about how funding from Recorder 6 users is raised and spent, to best address the Recorder 6 user community's requirements and priorities.

#### **Steering Group Objectives**

- Establish a shared understanding of strengths, weaknesses, threats and opportunities in relation to Recorder 6 maintenance and development through working closely with the Recorder 6 developer community and listening to Recorder 6 users (/ potential users)
- Identify and monitor risks to continuing maintenance and development of Recorder 6 and (where possible) manage these risks
- Reinvigorate the Recorder 6 user community and oversee the development of systems for capturing Recorder 6 users' needs and requirements, so that this feedback can inform decisions on Recorder 6 maintenance and development, and how funding is allocated
- Identify short-, medium- and long-term priorities in relation to Recorder 6 maintenance and development and work with the Recorder 6 developer community to estimate likely costs of options to address these priorities
- Identify short-, medium- and long-term priorities in relation to how information about Recorder 6 is made accessible to users and potential users (i.e. through websites and user documentation) and work with Recorder 6 user support community to estimate likely costs of options to address these priorities
- Ensure Recorder 6 users have access to the best & latest available information on species names and designations through close working with the UK Species Inventory project and the Joint Nature Conservation Committee
- Oversee establishment of a new funding mechanism for Recorder 6 maintenance and development through the introduction of an annual licence fee, and keep this under annual review
- Develop and pursue longer-term funding strategies for Recorder 6 maintenance and development

- Oversee the establishment of a management organisation for Recorder 6 which will handle licence fee payments, hold budget, manage contracts with developers and be accountable to the Recorder 6 Steering Group
- Make decisions on how funding from the Recorder 6 licence fee is allocated (based on identified priorities), and instruct the Recorder 6 management organisation accordingly
- Grow the community of developers with the knowledge and skills required to maintain and develop Recorder 6, and encourage development of Recorder 6 as an open-source project.
- Maintain confidence in Recorder 6 as a tool for managing biodiversity data through development of a roadmap for future maintenance and development.

## Scope and Exclusions

All existing Recorder 6 functionality is considered 'in scope', subject to further review.

The Recorder 6 Steering Group's immediate focus is on the needs of Recorder 6 users in the UK and Isle of Man. However, we will actively seek opportunities to collaborate with Recorder 6 users in other countries, e.g. Germany and Luxembourg (where Recorder 6 is the main repository of the Luxembourg Museum's collections data)<sup>1</sup>.

## **Exclusions**

The Recorder 6 Steering Group is not actively seeking to address the needs of users of other biological recording software packages.

# Authority

The Recorder 6 Steering Group **makes decisions** on the design and implementation of the Recorder 6 charging model. It may also decide to pursue other fundraising opportunities.

The Recorder 6 Steering Group makes decisions on how funding from Recorder 6 users is allocated.

As the Recorder 6 Steering Group is seeking to encourage development of Recorder 6 as an open source project, it cannot dictate how development progresses (except where the work is being done under contract to the Recorder 6 management organisation). However, the Recorder 6 Steering Group will **recommend and encourage** good practices.

## Membership

## Steering Group members

The Steering Group will have up to 11 members, drawn from the Recorder 6 user community – including representatives of Local Environmental Record Centre, National Scheme & Society, organisational and individual users. The role of members is to represent the Recorder 6 user community, not just their own organisations.

The Steering Group will seek to avoid having individuals on the Steering Group who work on Recorder 6 development in a paid capacity – simply to avoid any possibility of perceived conflicts of interest.

A Chair will be appointed by members of the Steering Group.

Steering Group members have a right to vote on decisions.

# **Decision making**

The Steering Group will aim to make decisions on a consensus basis, but decisions can be made on a majority vote if required. If we come to decisions where the group appears to be split, and there is not a clear majority in favour of a particular course of action, we will look for opportunities to revisit proposals and achieve greater consensus behind them.

## Meetings

Meetings will be convened on as 'as required' basis, at least twice yearly.

Meetings may be held face-to-face, or via teleconference. We will aim to make it possible to join all meetings remotely, via Skype or teleconference.

A note-taker will be identified for each meeting.

## Reporting

The Steering Group will provide updates to Recorder 6 users via the 'Recorder Announcements' section of the NBN Forum. We will also seek to secure a space on the web where we can share information with Recorder 6 users, as well as stay in touch with users via an opt-in email list.

## **Resources and budget**

There is no budget for Steering Group meetings. Members are therefore asked to cover their own travel and subsistence costs. The meeting venue at the Angela Mormont Centre for UK Biodiversity, at the Natural History Museum in London has been made available for free.

Funds for Recorder 6 maintenance and development, generated through the introduction of a licence fee, will be held by the management organisation in a fully ring-fenced budget. It will be up to the Steering Group to make decisions on how this is spent.
