### 3) Summary of feedback from Outline Business Case [EW]

- Feedback from version 2 has indicated that there is greater emphasis on scoping studies than expected and that the future state has greater buy-in than is indicated.
- There is a need to continue our sense of momentum.
- There is a need to be explicit about when the governance of NBN Scotland will commence.

 There is a need to more strongly link our business case to the State of Nature, Climate Emergency, Biodiversity Crisis and IPBES Global Assessment and the meeting of the Aichi targets.

We already have strong by-in from the community and the Outline Business Case perhaps has too much emphasis on Scoping Studies. From our early versions EW will now cast the implementation of the recommendations as a single investment programme with two tranches. These tranches allow choices to be made about pace and scope of delivery – for discussion under Item 4.

Our aim is to rapidly complete the Investment Case, following discussion with the Advisory Group, for submission by end of November.

EW to recast as an Investment Programme using the branding 'Investing in Nature – the Evidence'.

The Advisory Group needs to be very clear what is meant by 'NBN Scotland' as there still hasn't been a clear signal on this from NBN Trust. WH stressed that NBN Trust are a long way from being able to agree on NBN Scotland and that it needs to be very clear about who is making the decisions.

It was stressed that the first project is to find answers to the outstanding questions and, if the outcomes are different to those outlined in the SBIF Review, then Project 1 needs to explore how to still deliver the Review recommendations.

The Investment case should simply state our case, outline what the investment proposal would look like, set out delivery options and proposed projects, with an accompanying cover note.

It was discussed that we have a strong case to sell 'the infrastructure', the associated investment is in practical action to restore and preserve biodiversity – the infrastructure enables this to be more effective. The timescale is a decade.

GD acknowledge and thanked everyone for all the input into the previous drafts which have progressed the process to get us to here.

It was agreed that we still need to confirm the Governance of Programme (within Project 4 "Biodiversity Evidence Base" of the Scottish Biodiversity Strategy) and SNH will advise who will fill the role of Programme Exec.
