## 2) Development Officer Update [RT]

- Received NatureScot funding (many thanks to NatureScot for their ongoing support) for a development officer
- Organised and co-facilitated a workshop with NatureScot to explore priority benefits for SNH. Priorities were:

- Benefit 6: Organisations that provide or govern key parts of the infrastructure as a
  public service have sufficient funding and resource to do so effectively;
- Benefit 2: All data are of known quality, quickly and openly available and easily accessed through a single central data repository;
- Benefit 1: Clear data flows and submission points, with feedback on quality and use
- Supporting Cabinet Office/Geospatial Commission to finalise documentation for bid to undertake review of biological recording, and assess SBIF Recommendations, in an England context.
- Interviewed by JNCC as part of the Statutory Agency Review to evaluate the use of biodiversity data within country nature conservation bodies.
- Planning CIEEM workshop for 29<sup>th</sup> September with Claire Lacey to meet with data assistances within large environmental consultants
- Contact with DEFRA re. Cabinet Sec for Environment speech, follow up meeting with David Wood planned
- Submitted a response on behalf of SBIF to the ECCLR committee <u>call for views on the Green</u> Recovery

## 3) Welcome to Rona Sinclair

Rona Sinclair was welcomed the SBIF Advisory Group. Rona is working for NatureScot on SBIF related marine issues 2 days per week for the remainder of this financial year to identify any quick wins. She will apply her understanding of marine data and business analysis and build on existing internal and external contacts to take forward a scoping exercise for marine data as an adjunct to the Scottish Biodiversity Information Forum (SBIF) review. This exercise will:

- Consider the original SBIF review and NatureScot's subsequent prioritisation of recommendations and scope the works required to undertake a comparable review for Scottish marine survey data.
- Engage internal and external marine data stakeholders in the scoping exercise. The review should be informed by the new Scottish Marine Science Strategy and proposals to support Scotland's green recovery following Covid-19.
- Respond to ad-hoc SBIF-related marine data enquiries.

## 4) Facilitating enablers to support SBS Project 4 and a Green Recovery [EW]

A project proposal for the SBS Project 4, framing the SBIF Review in light of the Green Recovery was presented. Five objectives were discussed

- formation of "LERC Scotland" as a governance body and national hub to support provision of services for complete coverage of Scotland
- selection and implementation of a single, shared, supported online system for LERC data management and service provision
- streamlining of data flow and verification through enhanced integration with UKSI, iRecord and NBN Atlas
- design of a new, single framework agreement for NatureScot funding with LERCs and major recording groups
- capability and capacity building for LERC Scotland

There was overall support to progress the proposal and submit it at pace to NatureScot.

Key points of discussion included:

• The approach is a simple way to get things going and build upon. Starting with an umbrella organisation will provide a foundation to develop additional components of the SBIF Vision.

- It will demonstrate that there is parity across Scotland to provide access to data and report upon it
- Recognition that a single agreement model has worked well in other contexts (SE Link, ALERC single agreement with EA. This model, providing a single point of contact frees up time to do other work.
- Some concerns re. single shared systems and associated risks. Need to get scoping and questions right at outset and will require a formal tendering process to get the right solution
- Questions around how "LERC Scotland" works as a body (governance and fit with existing bodies). Scotland LERCs would like to speak to Welsh LERCs to understand if the model is the best it can be or if it can be improved upon.
- Some LERCs in Scotland are waiting to hear outcome before doing anything. Need to address their concerns and have dialogue from start even if can't address issues straight away.
- Clarity required on where this sits in relation to NBN Atlas Scotland and other existing infrastructure, it is to address coordinating the data management for the LERCs
- Need to be able to bring data together at different levels compatibility and building up data layers

## Opportunities

- Scottish Biodiversity Strategy will be published in 2022, if can have a skeletal team in place by then this could be an opportunity to make the case that "LERC Scotland" requires further funding
- Opportunity to get political buy-in to the "LERC Scotland" idea/SBIF review is to get it in to the manifestos for the elections in May

## Summary

- In right place for starting somewhere
- Need to be clear on scoping and emphasise need for a scoping phase
- Need to support LERCs that are struggling now
